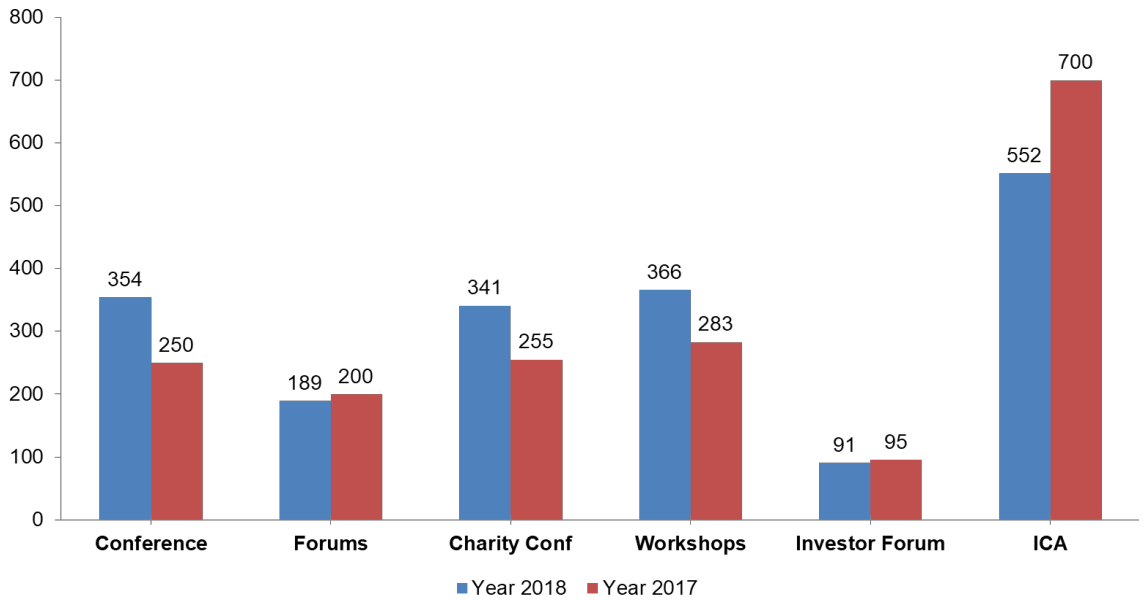

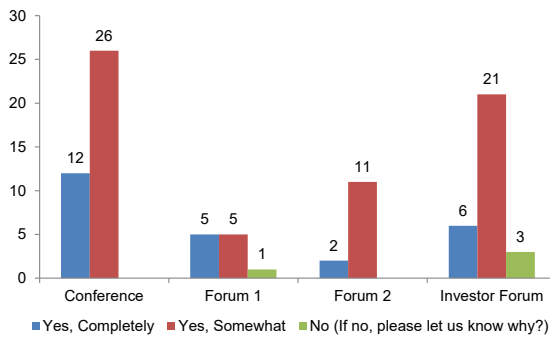

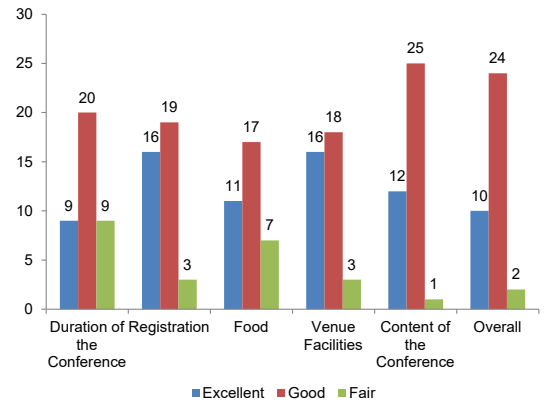
What are your reason(s) for attending this conference?
